Aware of the penal consequences in case of false statement (art. 495 of the Italian Penal Code) and the privacy information pursuant to art. 13 of EU Reg. 2016/679,

**Declares**, under her/his own responsibility:

- to be not aware of having come into contact with any confirmed case of COVID-19 in the last 14 days;
- to be not subjected to quarantine measures or fiduciary home isolation with health surveillance in accordance with the legislation in force;
- not to have symptoms of COVID-19<sup>1</sup>;
- to have been informed that access to the Terme di Saturnia facilities requires body temperature detection, and that access will be denied should the temperature be higher than 37.5 °C;
- to be aware that, if you intend to use the bar and restaurant services at the table, the current legislation provides for a social distance of one meter with the exception of people who, according to the current provisions, are not subject to interpersonal distance (joint and cohabiting partners). This last aspect belongs to individual responsibility.
- to have complied with the regulations issued by the Italian Ministry of Health and the World Health Organization about the following:
  - the possible obligation to undergo a mandatory swab with negative results if, in the 14 days prior to entry into Italy, you stayed or traveled through the states mentioned in the governmental directives;
  - to be aware that quarantine is mandatory for all citizens who have stayed in foreign states or countries mentioned in the governmental directives in the 14 days prior to arrival to Italy;
  - to be aware that entry into Italy is forbidden to citizens who in the previous 14 days have stayed or passed through foreign states or countries mentioned in the governmental directives.

Being aware of not being able to enter the premises of Terme di Saturnia if any of the dangerous conditions above exists, the undersigned commits to comply with the internal regulations and the official prevention and containment measures related to the spread of the virus.

**1. What are the symptoms of Covid-19?**

The most common symptoms of Covid-19 are fever, fatigue, and dry cough. Some patients may experience soreness and muscle pain, nasal congestion, runny nose, sore throat, or diarrhoea. These symptoms are generally mild and start gradually. In the most severe cases, the infection may cause pneumonia, severe acute respiratory syndrome, kidney failure and even death.

Recently, anosmia/hyposmia (loss/diminution of smell), and in some cases ageusia (loss of taste) have been reported as symptoms related to the Covid-19 infection (**SOURCE: MINISTERO DELLA SALUTE**)

*This information, supplementing the general one already adopted by Terme di Saturnia, complies with the official national measures for the containment of the Covid-19 spread, in order to protect our employees, collaborators and customers and ensure safe access to our premises. Personal data in the document are processed in order to prevent Coronavirus spread by implementing the infection control measures in accordance with the Protocol dated April 24, 2020 and the Decree dated March 11, 2020, as well as guarantee the safety of employees, collaborators and third parties on Terme di Saturnia premises..*

### 1. DATA CONTROLLER

Pursuant to art. 4, point 7, of the Italian Data Protection Act 2016/679, the data controller for the management of services related to hospitality, spa, restaurant and golf is the Terme di Saturnia S.p.a. company - 58014 Saturnia (Gr) – Italia, in the person of the hotel General Manager.

### 2. DATA PROTECTION OFFICER (DPO)

In accordance with article 37 of the RGPD 2016/679, Terme di Saturnia S.p.a. has officially appointed a Data Protection Officer (hereinafter referred to as DPO), whose contact details are: [dpo@termedisaturnia.it](mailto:dpo@termedisaturnia.it).

The DPO is available to relevant persons for any information concerning the processing of their personal data and the exercise of their rights.

### 3. TYPES OF PROCESSED DATA

These data are used to certify the absence of symptoms of Covid-19 virus. Personal data can be used with the only purpose to ascertain your health (art. 9, par. 1 del GDPR 2016/679) by means of body temperature detection to access Terme di Saturnia premises.

### 4. PURPOSE, LEGAL BASIS AND NATURE OF THE PROVIDED DATA

Filling in and signing the self-certification form stating the absence of Covid-19 symptoms is mandatory in order to access to Terme di Saturnia premises. Furthermore, the company will use infrared thermometers and face temperature screening systems in order to detect actual body temperature when entering the area. This is necessary to prevent spread of Covid-19 virus, pursuant to the national protocol “Protocollo condiviso di regolamentazione delle misure per il contrasto e il contenimento della diffusione del virus Covid-19 negli ambienti di lavoro” issued on March 14th, 2020 and modified on April 24th, 2020, and the directions of The Italian Data Protection Authority.

Detected body temperature will be not recorded, as per the anonymisation principle guaranteed by art. 5 of GDPR 2016/. The detection of body temperature has the only purpose to allow or deny access to Terme di Saturnia property, and it has its legal basis in the necessity to comply with a legal obligation of the Data Controller (art. 6 lett. c) del GDPR, that is the implementation of safety protocols against contagion pursuant the art. 1, n. 7, lett. d) of DPCM of March 11th, 2020, the guidelines for the reopening of productive activities issued by the Conferenza delle Regioni e delle Province autonome on May 16th, 2020 and DPCM of May 17th 2020.

The provision of personal data as per point 3 is mandatory in order to allow access to Terme di Saturnia premises. Access will be denied in case detected body temperature should be higher than 37,5° C (98.6 °F).

### 5. COMMUNICATION AND DIFFUSION

Your personal data will be processed by authorized personnel appointed by Data Controller. The authorized personnel is accurately trained regarding security of data and privacy rights.

Communication of your personal data to third parties can happen only if requested by specific law requirements, such as a request from the Health Authority in order to trace contacts with someone who tested positive to Covid-19. Your personal data will not be diffused.

### 6. DATA TRANSFERS

Your personal data will be not transferred to other countries or International Organizations.

### 7. DATA RETENTION

All personal data collected will be kept by the Data Controller until the end of the national Sanitary Emergency due to Covid-19 pandemic. After the end of emergency, all personal data will be canceled. The personal data regarding reservations will be kept for 14 day in accordance to current legislation.

### 8. RIGHTS OF THE RELEVANT PERSON

In accordance with Chapter III of the RGPD 2016/679, you have the right to request, at any time, access to your Personal Data, rectification or cancellation of such Data, refuse its processing, limitation of the processing, refuse the profiling and to lodge a complaint with the Supervisory Authority. You also have the right to withdraw your consent at any time without prejudice to the lawfulness of the processing based on the consent given prior to the withdrawal.
